Following are the minutes of the meeting-

1. Staff Council unanimously approved the short course on 'Better Process Control' in the department of Food Technology in collaboration with US- FDA (United State Food & Drug Administration). The course will be for five days(1st to 5th March 2011). Participants for the course are food Industry professionals and B.Sc.(H) Food Technology students of the college.
2. The house also approved short term course in 'Embedded Systems' to be organized by Department of Instrumentation. The course is consisting of six modules, total number of contact hrs. is 40. Undergraduate students of B.Sc(H) Computer Science/Electronics/Instrumentation/ Physics are eligible for the same.

3. The house unanimously recommended that the fee structure for the short term course may be increased from 2000/- to 3000/- (Without Practical) and from 3000/- to 4000/- (with Practical) respectively with the approval of Governing Body.
4. The house suggested taking a feedback form for the students of the course at the end of the Short term course.
5. Chairman, Staff Council introduced and welcomed all the new members appointed in various departments.
